Electricity There is no electrical supply to the Trade Stand area. Diesel generators are permitted on the understanding that they are used and stored safely. Exhibitors are not permitted to offer catering or sell food or drink from their stand. All catering must be arranged through Tavern Management, contact Tel: 07887 775161 or email davidsalt1963@gmail.com for details Site set up is permitted from 17:00hrs on the day prior to the event or before 9:00hrs on the day of the event itself.
